

MID-COURT[™] Water-Based Dust Mop Treatment

DESCRIPTION

A modern wax base dust mop treatment formulated for use on all mops and floor surfaces, to increase mopping efficiency, reduce dust, and decrease floor wear. Manufactured from special dust absorbing waxes activated with humectants, safe solvent cleaners, emulsifiers and air fresheners, designed to stay active longer.

DIRECTIONS FOR USE

Removes loose soil and dust, beautifies and protects floors and other hard surfaces, and prevents flying and residual dust. Ideal for dusting and cleaning all types of floors, paneling, plastics, chrome-plated surfaces, formica, metals, glass, painted surfaces, cement, terrazzo, marble, light fixtures, and other hard surfaces. Replaces floor and mop oils and old-fashioned sweeping compounds.

Initial Dust Mop Treatment:

To initially prepare untreated dry mops for use on wood floors apply 1 ounce of MID-COURT[™] per every 6 inches (see the table below), allow it to stand and absorb into the mop fibers for at least 8 hours before using.

Periodic Dust Mop Re-treatment:

Retreat dry mops for use on wood floors apply 1 ounce of MID-COURT[™] per every 12 inches (see the table below), allow it to stand and absorb into the mop fibers for at least 8 hours before using.

Size of Mop	<u>Amount</u>
12"	1 oz.
18"	1.5 oz.
24"	2 oz.
36"	3 oz.
48"	4 oz.



Dust Mopping Procedures:

For best results, floors should be dust mopped daily, or more often in very dirty areas.

Use a properly pre-treated and prepared dust mop.

Dust mop the floor in long paths. Do not lift the dry mop from the floor when turning corners.

After dust mopping the floor, shake out the mophead to remove loosely clinging dirt and to keep it clean. Store dry mops hanging up, not on the floor.

NOTE: Do not apply MID-COURT[™] directly to the floor. If excess treatment is left on the floor and it is slippery, use a dry untreated dry mop to absorb the excess.

Maintenance Instructions:

Wash dirty dust mops with detergent and water. Dry and retreat following instructions for initial dust mop preparation.

Dust Cloths:

For dust cloths, saturate with treatment, wring out excess, and allow to dry before use. Wash with soap or detergent solution, rinse, and dry before reuse.
