### DIRECTIONS FOR USE

NOTE: Shake well before using. Hold can upright and away from your body.

SPACE SPRAYING: Spray uniformly around room or area needing treatment. Allow 10-20 seconds for product to bloom.

SURFACE SPRAYING: Hold can 12-16 inches away from surfaces. Spray uniformly over odor causing substance or surface. Allow 10-20 seconds for product to bloom and settle onto surface. Do not saturate fabrics or textiles.
