### DIRECTIONS FOR USE

**DISPENSING DIRECTIONS:** Attach READY-SET-CLEAN® (RSC) Dispensing Unit to the bottle by threading the unit onto the bottle and tighten securely. Attach water hose to the unit and dispense product by squeezing the flow control handle.

**NOTE:** The READY-SET-CLEAN® Dispensing Unit is designed for use with any and all RSC products. Dilution tips built into the product containers provide precise, accurate dilution for every product, every time.

**DIRECTIONS FOR USE: FOR SPRAY & WIPE APPLICATIONS:** Dispense Earth Sense® Glass & Window Cleaner solution from the READY-SET-CLEAN® Dispensing Unit into a spray bottle at a dilution rate of 1:100 (1.3 oz per gallon) with the appropriate Ready-to-Use label affixed and tighten trigger sprayer. Use cold tap water only. Apply cleaner solution onto a clean microfiber cleaning cloth. Using the moistened microfiber cloth, apply cleaner to surfaces and scrub as needed. Then wipe dry with a clean microfiber cleaning cloth. For use on all glass, windows, mirrors, Plexiglas surfaces.

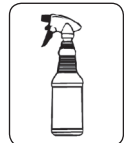
