### DIRECTIONS FOR USE

**CARPET PREPARATION** (Carpet must be cleaned before treatment)

- 1) Vacuum carpet and remove spots
- 2) Check carpet for color fastness; if OK, proceed to clean carpet using steam extraction method

#### APPLICATION OF SHIELD CARPET PROTECTOR

**For damp clean carpets:** Dilute SHIELD PLUS at a rate of 32 oz. per gallon (1:4) Spray solution uniformly over entire carpet at the rate of 1 gallon for each 200 sq. ft. of carpet.

**For dry carpets:** Dilute SHIELD PLUS at a rate of 16 oz. per gallon (1:8) Spray solution uniformly over entire carpet at the rate of 1 gallon for each 100 sq. ft. of carpet.

- Immediately after spraying, work product into carpet with a pile setting brush or pile lifter. To insure uniform appearance, brush in one direction after working product into carpet.
- If product comes into contact with painted or wood surfaces, wipe immediately with a damp cloth or sponge.
- Protect carpet from rust marks by placing aluminum foil or plastic on furniture legs until dry.
- Rinse all equipment thoroughly, immediately after each job is completed.

Note: Pre-test carpet coating on all types of carpet to insure proper acceptance of the product. When carpet is sprayed, make sure there is adequate ventilation.
