Easy to use oil type mop, dust cloth and floor treatment. Highly effective dust mop treatment made from refined, high-flash mineral oils, dust attractants, fresheners and special cleaners.

#### **DIRECTIONS FOR USE**

This is a specially compounded liquid mop and floor dressing for use on dust mops. It is important that it should be used sparingly. Reduces maintenance problems since it eliminates excessive airborne dust.

Initial Preparation:

To initially prepare untreated dry mops for use on resilient floors (including vinyl, asphalt, rubber and linoleum) apply the amount of TREATCO recommended in the table below to the mop, allow it to stand and absorb into the mop fibers for at least 8 hours before using. Treat dry mops for use on wood floors with the amount of TREATCO recommended in the table below to the mop, allow it to stand and absorb into the mop fibers for at least 8 hours before using.

After mopping the floor with a treated dry mop, shake out loosely clinging dirt from the mophead to keep it clean. Store dry mops hanging up not on the floor.

Maintenance Instructions:

Wash dirty dust mops with detergent and water. Dry and retreat following instructions for initial preparation.

NOTE: Do not apply TREATCO directly to the floor. If too much treatment is left on the floor and it is slippery, use a dry untreated dry mop to absorb the excess.
