DESCRIPTION

A state of the art, highly concentrated rotary and dry foam shampoo designed for safely maintaining all types of carpeting including stain resistant carpets. High foam formula deep cleans and brightens carpet. BURST PLUS™ incorporates our exclusive EPT™ encapsulation technology to surround and encapsulate soils, then it dries to a non-sticky powder. Soil and residue vacuum out easily. Carpets become amazingly clean and remain clean longer! Exclusive anti-re-soiling technology helps carpet resist dirt and soil from becoming entrapped.

- Neutral pH base and does not contain anti-static agents, defoamers, or optical brighteners / Safe for all washable carpeting including stain resistant carpeting

DIRECTIONS FOR USE

Designed for both rotary machine and dry foam machine application. Safe for use on stain resistant carpeting and other types of carpeting. Can be used in hotels, motels, schools, offices, airports, hospitals, nursing homes, restaurants or any facility to maintain quality carpeting.

Directions:

- 1) Pretest carpet for colorfastness in an inconspicuous area.
- 2) Remove furniture and dry vacuum thoroughly.
- 3) Pretreat spots and traffic lanes with SOIL FIGHTER PLUS.

For Rotary Machine

- 1) Dilute BURST PLUS 1:21 with water (6 oz. per gallon of water).
- 2) Shampoo across carpet in overlapping passes.
- 3) Avoid over wetting carpet and if available use vacuum to pick up excess liquid.
- 4) Brush carpet in one direction with deck brush or pile brush.

- 5) Do not walk on carpet until completely dry.
- 6) After carpet is dry vacuum thoroughly.

For Dry Foam Machine

- 1) Dilute BURST PLUS 1:12 with water (10 oz. per gallon of water) for normal soils and 1:8 (16 oz. per gallon of water) for heavy soils.
- 2) Shampoo across carpet in overlapping passes.
- 3) Brush carpet pile in one direction with deck brush or pile brush.
- 4) Do not walk on carpet until completely dry.
- 5) After carpet is dry vacuum thoroughly.

NOTE: Due to the variety of carpeting materials should be tested at recommended use dilution in an inconspicuous area. Use clean cloth or sponge for application and if test area indicates bleeding, color removal, carpet shrinkage or deterioration of adhesive, do not use.
