Non-Ammoniated Wax & Floor Finish Stripper

DESCRIPTION

A non-ammoniated, non-butyl stripper that removes floor finish, sealers and wax from resilient floor surfaces. This cost effective product utilizes wetting agents, amines, penetrants and synthetic detergents to safely remove modern day floor finishes.

DIRECTIONS FOR USE

A heavy duty stripper designed for complete safe and efficient removal of modern detergent resistant floor finishes, sealers and wax from all types of resilient and hard surface flooring.

For Light Detergent Resistant Floor Finish Build-up or Wax Removal: 1 part stripper to 16 parts water, or 8 oz. stripper to 1 gallon water.

For Normal Detergent Resistant Floor Finish Build-up or Wax Removal: 1 part stripper to 12 parts water, or 10 oz. stripper to 1 gallon water.

For Heavy Floor Finish Build-up or Wax Sealer Removal: 1 part stripper to 6 parts water, or 20 oz. stripper to 1 gallon water. Apply stripping solution liberally and allow to stand on the floor 5 minutes. Agitate with a floor machine equipped with a synthetic stripping pad. Remove the dirty solution of re-emulsified wax with a mop or wet vac. Rinse floor with clean water and allow to dry before rewaxing.
