DIRECTIONS FOR USE

(Note: Before use on fabrics, furniture, cars, clothing, bedding, etc. test spray area for color fastness.)

Restrooms, lockers, schools, hospitals, public buildings, zoos, kennels: Add deodorant (2-4 oz./gal) to cleaning solution for continuous long term action or spray areas with 10-12 oz. / gallon solution for immediate control of odors.

Spraying: Add 8-10 oz. of deodorant per gallon of water. Use as a space spray indoors or outdoors on garbage, industrial wastes, incinerators, kennels, sewage lagoons, sludge beds and other area where odors are a problem.

Addition to cleaners: Add 2-4 oz. of deodorant per gallon of cleaning solution. Provides immediate and long term control of malodors on floors, carpets.
