DIRECTIONS FOR USE

This versatile formula can be used in all food processing facilities. Excellent for cleaning grills, rotisseries, stove burners, overhead vents, electric frying pans and accessories.

Shake well before use. Spray all surfaces evenly from a distance of 9-12 inches. Use in either warm (200° F or lower) or cool empty oven. Allow foam to work 5-10 minutes on warm surfaces, 10-20 minutes on cool surfaces. Rinse thoroughly with water. Preheating the oven to 150° F - 200°F will promote rapid cleaning of burnt-on soils.
