DISPENSING DIRECTIONS: Attach READY-SET-CLEAN® (RSC) Dispensing Unit to the bottle by threading the unit onto the bottle and tighten securely. Attach water hose to the unit and dispense product by squeezing the flow control handle. Use the locking switch if desired for "hands-free" filling of buckets and automatic scrubbers. Ideal for urine odor removal.

DIRECTIONS FOR USE: FOR SPRAY & WIPE/MOP & BUCKET/ AUTO SCRUBBING APPLICATIONS: Dispense SHA-ZYME™ Cleaner solution from the READY-SET-CLEAN® Dispensing Unit into a sprayer, mop bucket or automatic scrubber at a dilution rate of 1:32 (4 oz per gallon). Use cold tap water only. For Spray and Wipe Applications: Apply cleaner solution directly onto the surface to be cleaned. Allow solution to penetrate grease and soils. If needed, brush with a stiff bristle brush. Wipe dry with a clean microfiber cloth. For Mop & Bucket/Autoscrubbing Applications: Apply cleaner solution using a mop or automatic scrubber. Allow solution to penetrate grease and soils. If needed, brush with a stiff bristle brush. Remove solution from the floor. Rinse if necessary.
